4       LICENSING ACT 2003 – APPLICATION FOR REVIEW OF THE PREMISES LICENCE IN RESPECT OF THE KEY STORES, 5 PARK PLACE, DOVER CT16 1DF

Members were reminded that an application for review of a premises licence under Section 51 of the Licensing Act 2003 had originally been made by the Responsible Authority Kent Police and had been the subject of a hearing on 4 August 2009. That Sub-Committee had decided to suspend the licence for a period of three months.

Subsequently the licence holder had appealed to the Magistrates' Court against the decision. The Court had upheld the Sub-Committee's decision to suspend the licence but had felt that two months was not proportionate and directed that a shorter period of suspension be imposed. The application had therefore been remitted to the Licensing Authority for a new hearing.

In accordance with the approved procedure representations were received from the Licence Holder's representative and the Responsible Authority Kent Police.

RESOLVED: That the previous suspension of the premises licence in respect of Key Stores, Park Place, Dover be reduced by 50% to 28 days as set out in the Notice of Determination 006/2010.
