1. Summary

This report has been produced to provide SKC Health and Wellbeing Board Members an update on the progress of the Accommodation Strategy being developed by KCC Families and Social Care, the detail the initial findings of the Evidence Base and the next steps.

2. Introduction and Background

A report was presented to the October SKC Health and Wellbeing Board detailing the need for a joined up integrated strategy to identify the accommodation needs of vulnerable people. KCC is leading the development of the Strategy with support from Kent Housing Group and the Joint Policy and Planning Board (housing). The Evidence Base is near completion and some initial findings can be shared. Clinical Commissioning Groups are encouraged to contribute to the development of the Strategy and to align the timescales of the development of their Commissioning Plans particularly in relation to Intermediate Care and the review of Community Hospitals. The documents (Evidence Base, Strategy and District Profiles) are in the process of being finalised to share with colleagues in the CCG's and other stakeholders so that full engagement and ownership can be achieved.

4. Next Steps

Previously reported was a timetable detailing how the different phases would be taken forward, however in order to make the Accommodation Strategy more rich, the phases will be merged and will include more detailed discussions with the CCG's so that their 2 and 5 year plans can be factored in. There are some priority areas that need to be addressed between now and March 2014 and this work will continue; this is in relation to the KCC inhouse residential care homes that need to be reviewed as part of Facing the Challenge (KCC's whole Council transformation programme).

District Councils and other key stakeholders will also be taken through the steps and stages to make sure that forecasts reflect existing activity, planned activity in relation to preventative and community services and other influences that affect both current and future capacity in the coming weeks.
