## General Exception

Pursuant to the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

### Notice of Key Decision

**A: Decision to be taken and by whom**

To receive the recommendations from the Scrutiny (Policy and Performance) Committee and to consider the independent business case for establishing a new single district council in east Kent.

Decisions to be taken by Cabinet at its special meetings on 20 and 23 March 2017.

This is a Key Decision which has not been included within the Notice of Forthcoming Key Decisions, but which must be taken by such a date that it is impracticable to defer the decision until 28 days after the next Notice is published.

**B: Reasons why this Key Decision was not included in the Notice of Forthcoming Key Decisions and why it would not be practicable to defer the decision**

Due to an oversight, this decision was not included in the Notice of Forthcoming Key Decisions. To adhere to the decision-making timetable for all of the councils involved, it is not practical to defer the decision.
