General Exception

Pursuant to the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

Notice of Key Decision

A: Decision to be taken and by whom

To approve a local scheme for the administration of the Government's Discretionary Relief Fund in relation to Business Rates.

Decision to be taken by Cabinet on 11 September 2017.

This is a Key Decision which has not been included within the Notice of Forthcoming Key Decisions, but which must be taken by such a date that it is impracticable to defer the decision until 28 days after the next Notice is published.

B: Reasons why this Key Decision was not included in the Notice of Forthcoming Key Decisions and why it would not be practicable to defer the decision

Due to an oversight, this decision was not included in the Notice of Forthcoming Key Decisions. To ensure that businesses adversely affected by the Government's revaluation of business rates receive prompt relief, it is considered important not to delay the distribution of funds any further by deferring the decision.
