Reason for the Decision:	To nominate a Member as Dover District Council's representative on the South Kent Coast Health and Wellbeing Board. This follows former Councillor Paul Watkins' resignation at the end of September, and changes made to Cabinet portfolios by the new Leader of the Council.
Decision:	To nominate Councillor Nicholas Kenton, Portfolio Holder for Environment, Waste and Health, to serve as the Council's representative to the South Kent Coast Health and Wellbeing Board for the period ending May 2018.

1. **Consideration and Alternatives (*if applicable*)**
 - 1.1 Dover District Council is entitled to have two representatives on the South Kent Coast Health and Wellbeing Board. Councillor Pauline Beresford is currently a member of the Board and it is proposed that she should remain a member. However, there is a need to replace former Councillor Paul Watkins who resigned in September. Councillor Nicholas Kenton has recently assumed the health portfolio, and it is proposed that he should replace Councillor Watkins.
