GENERAL EXCEPTION NOTICE – (GE02 23) ACCEPTANCE OF FUNDING FROM LOCAL AUTHORITY HOUSING FUND (ROUND 2)

General Exception

Pursuant to the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

Notice of Key Decision

A: Decision to be taken and by whom

Acceptance of funding of £840,000 awarded from the Local Authority Housing Fund Round 2

Decision to be taken by Mike Davis, Strategic Director (Finance and Housing) and Section 151 Officer under delegated powers

This is a Key Decision which has not been included within the Notice of Forthcoming Key Decisions, but which must be taken by such a date that it is impracticable to defer the decision until 28 days after the next Notice is published.

B: Reasons why this Key Decision was not included in the Notice of Forthcoming Key Decisions and why it would not be practicable to defer the decision

Round 2 Funding was provisionally awarded to Local Authorities by the Department of Levelling Up, Housing and Communities on 7 June 2023. If the Council wishes to accept the funding offered (and the terms of the LAHF round 2), a validation form needs to be completed by 5 July 2023, with a Memorandum of Understanding to be signed by 19 July.

The award of funding could not have been foreseen when the relevant Notice of Forthcoming Key Decisions was published on 28 April. Furthermore, the tight deadlines mean that the decision cannot be deferred until Cabinet next meets on 5 July.
