1. Summary

The Cost-of-Living Community Impact Fund Appraisal Panel met on 1 December 2023 to consider applications submitted under the Cost-of-Living Community Impact Fund (formerly known as the Community Grants Scheme). The Panel recommended that the organisations/bodies referred to in paragraph 2.7 of this notice should receive the grants requested. Using powers delegated by Cabinet in April 2018, the Community, Asylum and Transport Services Manager (acting on behalf of the Head of Community, Digital and Transformation (formerly the Head of Community Services)) is requested to approve the individual grants.

2. Background

- 2.1 As per the Council's Cost-of-Living Plan published on 10 August 2023, on 4 September Cabinet approved the updating of the Dover District Council Community Grants Scheme criteria, and the rebranding of the scheme as the Cost-of-Living Community Impact Fund (Cabinet decision CAB 30).
- 2.2 Cabinet also agreed a total grant pot of £85,277.29 for the 2023/24 Community Impact Fund. This included:

Dover District Council 2

- (a) £22,500 from the Dover District Council core funds.
- (b) £7,500 from the Dover District Lotto Central Fund Reserve (CFR), as approved by Cabinet in October 2018.
- (c) £30,000 from the UK Shared Prosperity Fund in the 2023-24 budget.
- (d) An underspend of £25,277.29 was available from the last round, totalling £85,277.29.
- 2.3 Finally, a social value donation from Aran Insulators of £1,500 was approved by the Leader of the Council, Cllr Kevin Mills, on 26 November 2023, providing a final grant pot of £86,777.29.
- 2.4 Eligible applicants include:
 - (a) Registered Charities
 - (b) Community Interest Companies
 - (c) Constituted Community Groups
- 2.5 Eligible spend includes:
 - (a) Capital Costs
 - (b) Consumable Costs
 - (c) Revenue Costs
