General Exception

Pursuant to the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

Notice of Key Decision

A: Decision to be taken and by whom

To consider the following reports:

- The award of the replacement flat roofing contract (2017-2020) (all subject to the completion of S20 consultation)
- The award of the replacement pitched roofing contract (2017-2020) (all subject to the completion of S20 consultation)
- The award of the replacement PVCu windows and doors contract (2017-2020) (all subject to completion of S20 consultation)

Decisions to be taken by Cabinet at its meeting to be held on 4 September 2017.
