7. INFORMATION FROM THE JOINT STAFF CONSULTATIVE FORUM

At the meeting of the Joint Staff Consultative Forum held on 18 January there was a request from Unison that Member panels for case appeals be re-introduced. After discussions, employees' representatives proposed that it be recommended to the General Purposes Committee that Member Panels for disciplinary and grievance appeals be reintroduced. On being put to the vote, the Forum failed to agree the recommendation as there was not a majority vote on both sides of the Forum (i.e. a majority of employee representatives *and* employer representatives). This failure to agree the recommendation is therefore being reported to the General Purposes Committee, in accordance with paragraph 12 of Section 7 of the Constitution. Members are requested to note the position.
