The Council is seeking to review options regarding the contractual arrangements to ensure that best value is obtained for the future provision of these services and is seeking to appoint experts within the industry to provide some independent advice on current best practice across the business sector. The proposed appointment of Land Management Services Ltd, to undertake a short review of current arrangements and to assess alternative options, will support this work.
