Declarations of Interest

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

20 APOLOGIES

Apologies for absence were received from District Councillors D G Cronk and D A Sargent and County Councillor G Lymer.

21 APPOINTMENT OF SUBSTITUTE MEMBERS

It was noted that, in accordance with Rule 4 of the Council Procedure Rules, Councillors M R Eddy and S F Bannister had been appointed as substitute Members for Councillors D G Cronk and D A Sargent respectively.

22 DECLARATIONS OF INTEREST

Mr K Gowland made a Voluntary Announcement of Other Interests in Agenda Item 10 (Proposed Waiting Restrictions – Archers Court Road, Whitfield) by reason that he had instigated the proposal.

23 MINUTES

The Minutes of the meeting held on 7 September 2017 were approved as a correct record and signed by the Chairman.

24 <u>RECEIPT OF PETITION - BEACONSFIELD AVENUE TRAFFIC-CALMING MEASURES</u>

The Chairman received a petition from Mr D Overal in respect of traffic-calming measures in Beaconsfield Avenue, and advised that it would be passed on to the Kent County Council (KCC) Cabinet Member who would respond.

25 BUS/COACH PARKING PROPOSALS - DOVER SEAFRONT

The Highways and Parking Team Leader (HPTL) presented the report which set out proposals for bus and coach parking at the seafront. The background to the proposals was set out in paragraphs 2 and 3 of the report. At its meeting held on 16 March, the Board had resolved that coach parking should be provided in Waterloo Crescent, outside and opposite Harbour House, and this proposal had been advertised. Following consultation, two objections had been received from the Port of Dover and the Dover Society that were primarily concerned with highway safety issues. Alternative options had been exhausted and, subject to Kent County Council Highways' approval on safety grounds, Members were requested to agree that the proposal be implemented by sealing the requisite Traffic Regulation Order.

RESOLVED: That it be recommended that the bus/coach parking proposal set out at Appendix A of the report be implemented by Kent County Council sealing the necessary Traffic Regulation Order.

26 <u>LORRY PARKING PROHIBITION - COOMBE VALLEY, BARWICK AND</u> FOLKESTONE ROADS, DOVER

The HPTL introduced the report which outlined proposals to prohibit lorries parking in Barwick, Coombe Valley and Folkestone Roads, Dover. At its meeting held on 7 September 2017, the Board had approved the proposals for consultation. Although the consultation period had not expired, there was a need to progress the proposals as quickly as possible and it was therefore proposed that, rather than waiting for the next meeting of the Board in March, any objections received would be considered by the Chairman and Vice-Chairman.

The HPTL clarified that, whilst the Council could enforce double yellow lines by issuing Penalty Charge Notices, it did not have the powers to move lorries on. The police could enforce double yellow lines but generally left this to the Council. Councillor P Walker urged KCC Members to resolve the wider problem of lorry parking across Kent. Councillor Collor reported that KCC continued to look at potential sites for a lorry park. KCC and Ashford Borough Council had been involved in a joint venture to clamp illegally parked lorries but this had proved financially prohibitive.

RESOLVED: That the Chairman and Vice-Chairman be authorised to consider any objections received, and to decide thereafter whether to progress all or any of the proposals set out in Appendices A1 to A3 of the report.

27 PARKING PROHIBITION PROPOSAL - MARINE ROAD, WALMER

The HPTL introduced the report which set out proposals for prohibiting parking at Marine Road, Walmer as a result of the refurbishment of the car parking area adjacent to Deal Castle.

Councillor M R Eddy welcomed the proposal which would make the car park entrance wider and therefore safer for vehicles entering from the busy main road.

Councillors Eddy and A Friend commented that the improvements justified the loss of three or four on-street parking spaces.

RESOLVED: That it be recommended that the parking prohibition scheme set out at Appendix A of the report be formally advertised and, in the event that no objections are received, sealed by Kent County Council. Any objections received to the formal advertisement will be referred back to a future meeting of the Board for further consideration prior to making any final recommendations.

28 RESIDENTS' PARKING SCHEME - NORTHCOTE ROAD, DEAL

The HPTL presented the report which detailed proposals for the inclusion of Northcote Road into the Zone L residents' parking scheme. The road was now being used by a significant number of non-residents, and some residents had now requested that the road be included in Zone L. The removal of parking on one side of the road would lead to the loss of eight parking spaces. Following consultation, seven letters of support and five letters of objection had been received.

RESOLVED: That it be recommended that the inclusion of Northcote Road in the Zone L Parking Scheme, as set out at Appendix A of the report, be formally advertised and, in the event that no objections are received, sealed by Kent County Council. Any objections received to the formal advertisement will be referred back to a future meeting of the Board for further consideration prior to making any final recommendations.

29 PROPOSED WAITING RESTRICTIONS - ARCHERS COURT ROAD, WHITFIELD

The Schemes Programme Manager presented the report which outlined proposals to make temporary waiting restrictions in Archers Court Road permanent. Whitfield Parish Council had requested that they be made permanent, and consultation on the proposal had been undertaken. Councillor J S Back welcomed the proposal which had made a significant difference to traffic flow in Archers Court Road.

RESOLVED: That it be recommended that the proposed waiting restrictions, as set out at Appendix A of the report, be made permanent.

30 PROPOSED WAITING RESTRICTIONS - HAMILTON ROAD, DEAL

The Dover District Manager (DDM) introduced the report which detailed proposals to implement waiting restrictions by the entrance to Goodwin Academy. The proposal was designed to improve the sightlines for drivers and children outside the school. Following consultation, objections had been received and the original proposal had been amended to a Monday to Friday, 8.00 am to 6.00 pm restriction.

Councillor Friend commented that Goodwin Academy had a duty to secure the safety of students. However, it was unfortunate that the residents of Hamilton Road, where parking was already under pressure, would be adversely affected by the proposal. Councillor Eddy echoed these views, adding that removing parking spaces could increase problems with speeding traffic. Councillor Bond suggested that, rather than an all-day ban, restrictions should be limited to the school's drop-off and pick-up hours (e.g. 8.00am to 10.00am and 2.00pm to 4.00pm). He also suggested that school holidays should be excluded.

The HPTL advised that school zig-zag or keep clear markings were preferable to double yellow lines as timings could be controlled and they were easier to enforce than yellow lines. However, lifting the restrictions during school holidays was a problem because the dates of these varied, and the signage used to enforce the restrictions had to be completely accurate.

RESOLVED: That the Schemes Project Manager (Dover) be requested to investigate the possibility of 'School Keep Clear' markings and a report be brought back to the Dover Joint Transportation Board.

31 PROPOSED CLOSURE TO TRAFFIC - AUSTINS LANE, SANDWICH

The DDM introduced the report which set out proposals to close Austins Lane to traffic by installing removable bollards at each end. Although objections had been received, the proposals had the support of all the residents of Austins Lane and Sandwich Town Council.

RESOLVED: That it be recommended that the proposal be progressed to formal consultation in order for the Traffic Regulation Order to be made.

32 LOCAL WINTER SERVICE PLAN

The DDM presented the report which explained arrangements made between KCC and Dover District Council (DDC) to provide highway services in the event of significant snowfall. Members were advised that DDC's waste staff were tasked with carrying out localised salting. A good deal of assistance was also provided to rural communities by farmers. It was explained that, whilst it would be good to have more gritters standing by, this would be a waste of resources given that they were usually needed for only a few days a year. KCC's priority was to keep primary and secondary routes open, with other routes tackled as and when resources allowed. Members were reminded that, during such events, KCC posted a good deal of information on Twitter and Facebook.

RESOLVED: That the report be noted.

33 HIGHWAY WORKS PROGRAMME 2017/18

Members received the report which provided an update on schemes that had been programmed for delivery in 2017/18. The DDM advised that the only scheme outstanding in Appendix A was the work to the Copart roundabout which would be completed by March 2018.

RESOLVED: That the report be noted.

34 EXCLUSION OF THE PRESS AND PUBLIC

RESOLVED: That, under Section 100(A)(4) of the Local Government Act 1972, the public be excluded from the meeting for the remainder of the

business on the grounds that the item to be considered involves the likely disclosure of exempt information as defined in

paragraphs 1 and 2 of Part I of Schedule 12A of the Act.

35 APPLICATIONS FOR DISABLED PERSONS' PARKING BAYS

The HPTL introduced the report which outlined details of eleven disabled persons' parking bay applications. In addition, it was proposed that nine disabled parking bays should be removed as they were no longer required. Ten of the parking bay applications met all the criteria and it was recommended that they proceed to formal advertisement. The eleventh application did not meet the criteria and the Board's views were therefore sought. The HPTL confirmed that any objections received during informal consultation would also be counted as formal objections. In respect of Application K, it was clarified that there was a flight of steps leading from the applicant's garage to the house which were on an incline.

RESOLVED: (a) That it be recommended that Application K be formally advertised and, in the event that no objections are received, it be recommended for sealing by Kent County Council (with any objections being referred back to a future meeting of the Dover Joint Transportation Board for further consideration).

(b) That it be noted:

- (i) That Applications A to J would be formally advertised and, in the event that no objections are received, they be recommended for sealing by Kent County Council (with any objections being referred back to a future meeting of the Dover Joint Transportation Board for further consideration).
- (ii) That Applications L to T would be formally advertised with the intention of removing them and, in the event that no objections are received, their removal will be sealed by Kent County Council.

The meeting ended at 7.04 pm.

MOTOR HOME PARKING CONTROLS

Recommendation:

The Board is asked to agree to consult on proposals to introduce restrictions on the parking of motorhomes overnight on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer.

1. Summary

1.1 This report provides an update on the situation regarding the parking of motorhomes further to earlier reports to The Board and seeks agreement to consult on proposals to introduce restrictions on the parking of Motorhomes on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer.

2. Background

- 2.1 Concerns regarding overnight parking of Motorhomes, were first reported to the Board in September 2014. At that time, the focus of the concerns was the seafront areas in Dover and Walmer. The Board resolved:
 - (a) That an overnight ban from 6.00pm to 6.00am, Monday to Sunday, on motor caravans parking on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer be advertised.
 - (b) That officers be instructed to explore options for the provision of alternative parking for both sites, including holding discussions with third parties as appropriate.
- 2.2 Ongoing discussions ensued with the Port of Dover and others regarding the availability of alternative sites, with no clear options coming forward at that time.
- 2.3 This issue was then given thorough consideration during the development of the Parking strategies for Dover, Deal and Sandwich.
- 2.4 The Dover Parking Strategy notes that; "The analysis has also identified pockets of overnight on-street parking by motorhomes, as well as on-street coach parking. Whilst the introduction of overnight restrictions could be introduced, this is unlikely to be cost effective for the council in terms of an enforcement regime. A limited enforcement regime could still act as a deterrent and is likely to still considerably reduce the level of overnight parking. Similar approaches have been adopted by other seaside towns looking to keep their waterfront areas clear. A more proactive solution would be the identification of specific provision for motorhomes, as well as additional coach parking within the town."
- 2.5 Whilst the search for a permanent arrangement for the parking of motorhomes continued, proposals to introduce a small charge of £7.50 per night for motorhomes

choosing to park overnight on Dover seafront, was agreed by the cabinet at Dover DC in April 2017, although this has yet to be put into effect.

- 2.6 In taking any action on this matter it has always been recognised that there is a need to balance the interest of local residents, and the concerns they express regarding the parking of such vehicles, with the wider benefits to the local visitor economy of tourists arriving in Motorhomes.
- 2.7 However it has not been possible to identify realistic alternative locations, where Motorhomes might park and so this report acknowledges the difficulties involved in dealing with the legitimate concerns being voiced and seeks agreement to the introduction of limited controls on the parking of motorhomes.

3. **Proposed Controls**

3.1 Dover Seafront

The Council has over recent years received regular complaints from local residents regarding the impact of motorhomes parking on the seafront at Dover, which as can be seen from the following photos can sometimes be quite intrusive.









- 3.2 Equally, the Council in promoting White Cliffs Country as a tourist destination is keen to ensure that the Councils is doing all it can to support the local tourism economy.
- 3.3 In recent years the number of Motorhomes parking overnight has increased significantly with online forums such as campercontact.com, motorhomefun.co.uk, etc. actively promote Dover Seafront as a location where Motorhomes may park.
- 3.4 Most Motorhome appear to park overnight or for a relatively short term before catching a ferry, but there have been examples, especially in Walmer, of vehicles which appear to have been used for a lengthy stay.
- 3.5 Action can be taken against vehicles being used for long term accommodation through the Magistrates Court, but clearly this is not a cost effective approach to dealing with the issue.
- 3.6 The parking of Motorhomes overnight or longer on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer is detrimental to the amenity of the area and it is therefore proposed that this situation be addressed by introducing regulations to prohibit Motorhomes from parking on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer between the hours of 8.00 pm and 8.00 am

4. Identification of Options

- 4.1 Option 1. To agree to consult on the proposal to prohibit Motorhomes from parking on Marine Parade and Waterloo Crescent, Dover and The Beach, Walmer between the hours of 8.00 pm and 8.00 am.
- 4.2 Option 2. To amend the proposal outlined in option 1 as determined by the Board and to agree to undertake a consultation based on the revised proposal(s).
- 4.3 Option 3. To take no action.

3. Resource Implications

3.1 The funding will be covered by the Parking Operations budget.

Reasons why a decision is required

- At its last meeting on 30 November 2017, the Board discussed proposals to introduce further lorry parking prohibitions along the unrestricted sections of Barwick Road, Coombe Valley Road and Folkestone Road in Dover, as shown in Appendices A1 – A3 to this report.
- 2. In order to allow for a potentially quicker resolution, the Board resolved to authorise the Chairman and Vice-Chairman to consider any received objections to the advertised proposals and thereafter to decide whether to progress with all or any of them.
- 3. 11 people responded to the advertised proposals:
 - 5 supporting the proposals
 - 3 objecting (one person writing in twice)
 - 3 didn't commit either way, but made comments

All the responses were sent to the Chairman and Vice Chairman.

- 4. Having considered the responses, both the Chairman and Vice-Chairman agreed that the proposals should proceed, as advertised.
- The necessary paperwork has since been forwarded on to Kent County Council to enable the proposals to be sealed. The new prohibitions will come into effect on 1 May 2018.







PARKING PROHIBITION PROPOSAL FOR MARINE ROAD, WALMER

Recommendation:

The Board is asked to agree:

To recommend to Kent County Council that the parking proposal detailed in this report and shown as Appendix A be sealed, so as to bring the proposed restriction in to effect.

Reasons why a decision is required

- 1. Members will be aware of the refurbished car parking area adjacent to (and to the south of) Deal Castle which English Heritage has undertaken and that has planning permission to operate as a "Pay & Display" car park.
- 2. As part of the works, a new vehicular access has been created off Marine Road and the old access off the A258 Victoria Road in Deal has been closed. The Kent County Council Highway Planner had agreed to the new access off Marine Road providing that the on-street parking currently permitted along the northern limb of Marine Road be prohibited during the daytime.
- 3. At its last meeting on 30 November 2017, the Board resolved that the requested proposed parking restrictions along Marine Road and as shown in Appendix A be formally advertised. Further, that should any objections to the proposals be received that they be considered by the Board prior to making any final recommendations.
- 4. The proposal was formally advertised and two objections received; one from a local Councillor, the other from a member of the public. One email supporting the proposal was also received. These are attached as Appendices B D to this report.



Reasons why a decision is required

- 1. The problem of finding alternative Pay & Display bus/coach parking along Dover seafront has been on-going since the stopping-up (closure) of the Esplanade at the western end, over a year ago.
- Several options have been considered and at its last meeting on 30 November 2017, the Board resolved that it would proceed with the last proposal, as shown in Appendix A, for 4 coach spaces; a pair outside and a pair opposite Harbour House, subject to a final safety approval from Kent County Council.
- 3. Unfortunately concerns had been raised by KCC about the proximity of western most pair of spaces closest to the pedestrian crossing feature outside the front door to Harbour House and how the sight-lines for pedestrians using it would be restricted trying to look out into the road beyond these coaches.
- 4. To address this, a proposal to relocate the western most pair of coaches to the eastern end of the seafront has been designed as shown in Appendices B and C. This proposes that there will be 2 coach spaces at the western end of the seafront (outside Harbour House) and 2 spaces at the eastern end (outside the Premier Inn).
- 5. The Board is asked to agree that the revised coach parking proposal detailed in this report and shown in Appendices B and C, be formally advertised and in the event that no objections are received, is recommended to be sealed by Kent County Council. Any objections received will be reported back to a future meeting of this Board for further consideration prior to making any final decisions.







PROCEDURE FOR DETERMINING APPLICATIONS FOR ON-STREET DISABLED PERSONS' PARKING BAYS

- 1. Under the current arrangements with Kent County Council (the Highway Authority), an applicant has to satisfy a list of criteria set by the County Council in order to qualify for a disabled person's parking bay being provided outside, or close to, his or her house. The set of criteria was adopted by this Board at its meeting held on 7 February 2005 and is as follows:
- All applicants must hold a current and valid Blue Badge
- All applicants must also be in receipt of, or have proof of entitlement to:

Personal Independence Payment (PIP) at the enhanced rate or

If under 65 years of age - entitlement to the higher rate mobility component of the Disability Living Allowance **or**

If 65 years or over — entitlement to the Higher Rate of Attendance Allowance if applicant was 65 years or over when entitlement was first claimed **or**

Another entitlement which may be allowable e.g. War Pension.

- The applicant must not have any space available for parking their vehicle in an offstreet parking facility.
- There are parking problems within the road, for example, the applicant regularly has difficulty finding available space on-street close to his or her property (this will be assessed post-application by a highway engineer).
- 2. Bays will not be provided in locations which may compromise public safety, e.g. on a bend or brow of a hill, close to a junction, within a turning head of a cul-de-sac, where the road is too narrow or where parking is already prohibited, e.g. on yellow lines, zigzag lines, etc.
- 3. The provision of a disabled persons parking bay **must** relieve congestion on the public highway.

Process after receipt of application

- 4. Providing the applicant meets the criteria set out above, the first stage in processing the application is that neighbours who may be immediately affected by the provision of a bay will be informally consulted.
- 5. Once informal consultation has been completed, the proposals (including any objections received) will be reported to the Dover Joint Transportation Board which will make an initial decision on whether the application should be refused or progressed to the second stage of formal advertisement and consultation. A

- recommendation to refuse the application would be made to Kent County Council and would mean that the application proceeds no further.
- 6. If the Board agrees that the application should be progressed to the second stage, a Traffic Regulation Order (TRO) will be made. This is a legal document that allows the Highway Authority to regulate the use of bays and helps to prevent their misuse. The proposed TRO will be advertised in a local newspaper and affected parties will be formally consulted.
- 7. At this stage, a bay may be marked on the highway. However, it will not be enforceable until the TRO has been formally made (or 'sealed').
- 8. If objections are received during the formal consultation stage, they will be reported to the Dover Joint Transportation Board for a further decision. In the event that Kent County Council accepts a recommendation from the Dover Joint Transportation Board to refuse an application, the interim bay will be removed. If the Board makes a recommendation to approve the application, the TRO will be sealed. (If no objections are received during the formal consultation stage, the TRO will be sealed without further reference to the Board.)
- 9. It should be noted that the applicant will not have exclusive rights to the parking bay. Anyone holding a valid Blue Badge may park in the bay.
- 10. A TRO can take between 9 and 12 months on average from when it has been agreed in principle to the time of implementation. It is a lengthy process due to the need for the Council to adhere to the statutory procedures laid down by the Department for Transport.
- 11. When a bay is established on the highway it will be assessed periodically against the criteria to ensure that it is still justified. If the bay is no longer required for the original use or the criteria are no longer met, it may be removed.
