The Covid-19 outbreak is having a significant impact on parking demand across the District and it is not appropriate to continue imposing charges within our off-street car parks and on-street parking bays.

It is therefore proposed that in accordance with Paragraph 17 of the Dover DC (Off-Street Parking Places) Order 2019 and the provisions within the Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005, charges within the off-street car parks and on-street parking bays managed by the Council are suspended until further notice. This includes the car parks managed by the Council on behalf of English Heritage at Walmer & Deal Castles subject to the agreement of English Heritage.

Arrangements will be made with business permit holders, to extend the duration of their permits by the length of this period of suspension.
