## C. State whether the arrangements/amendment(s) made affect executive members or officers:

The proposed change will give additional powers to Officers.

### D. State reasons for, and effect of, the arrangements/amendment(s):

The Government has recently introduced the Business & Planning Bill, which is expected to receive Royal Assent around the 6 July 2020. This introduces a concept of Pavement Licences, which means a streamlined route for businesses such as cafes, restaurants and bars to secure a licence to place furniture on the highway. This is intended to support them to operate safely while social distancing measures remain in place. At present, the draft legislation makes no reference to whether this function is to be discharged by the Executive or the Council. In the absence of any specific statutory provision, Section 9D of the Local Government Act 2000 provides that it shall be an Executive function and therefore the Leader is asked to delegate this to the Officers named above to allow these functions to be discharged.

In the event that the Bill, when made law, includes such a provision which makes this a Council function, the Regulatory Committee is also being asked to make identical delegations to officers, to ensure that these functions can be discharged in a timely way.
