1. **Consideration and Alternatives (*if applicable*)**

Dover District Council (DDC) applied to the Office for Zero Emission Vehicles (OZEV) for a grant to assist with the introduction of 49 electric vehicle charging bays, to be sited at various locations in Dover, Deal and Sandwich. The application was successful and on 6 January 2021 OZEV awarded the Council a grant of £224,270.

OZEV has stated in its award letter that signed confirmation of acceptance of the grant must be received by no later than 15 January 2021.
