#### D: Reasons why it is necessary to follow the Special Urgency procedure:

At its meeting held on 6 July 2020, Cabinet delegated authority to the Strategic Director (Corporate Resources), in consultation with the Portfolio Holder for Housing and Health, to take all necessary actions to progress a project to build affordable housing at Napchester Road.

Under the terms of the Section 106 planning agreement for the Whitfield Urban Expansion, to which Dover District Council is a party, the Council is required to sign the build contract for the construction of 26 affordable homes at Napchester Road, Whitfield concurrently with the transfer of the land from the current landowner. The transfer is due to take place this week, and the design and build contract will also therefore need to be signed. This decision was not included in the Notice of Key Decisions in time to meet the 28 days' notice requirement and it is therefore necessary to follow the Special Urgency Procedure. For the reason stated above, the decision cannot be deferred.
