#### 1. Summary

- 1.1 As part of the ongoing delivery of grounds maintenance and management of open spaces, there have been numerous pathways and fences in need of urgent attention.
- 1.2 The purpose of this report is to seek approval to undertake works to address the most urgent repairs to parks, gardens and churchyards as part of an ongoing programme of repair works.

#### 2. **Introduction and Background**

- 2.1 The nature of an in-house ground's maintenance service means staff are visiting a large proportion of the Council's assets and are able to identify areas of concern to either users or staff attending.
- 2.2 Supervisors and Team members continue to compile an ongoing maintenance programme of works which can be allocated to Property Services or, in the case of smaller and more immediate concerns, dealt with by the POS Team.
- 2.3 Emergency works have already been completed and costed to the POS revenue budget to ensure there is no delay or risk of injury to public and staff. This places an unnecessary pressure on the revenue budgets.
