34 LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976 - REVIEW OF A JOINT HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS' LICENCE

The Committee considered the report of the Licensing Enforcement Officer on a review of a Joint Hackney Carriage and Private Hire Drivers' Licence concerning the conduct of a driver licensed in the Dover district. The case was referred to the

Regulatory Committee to determine whether the driver remained a fit and proper person to hold a licence in the Dover district.

In accordance with the approved procedure the Committee heard from the driver and their representative regarding the complaint. They reiterated their submission as set out in the agenda papers and additionally provided further information that had not been set out in the papers. The Committee noted the cooperation of the driver and the driver's representative, and the actions implemented following the incident.

The Committee withdrew from the meeting, along with the legal advisors to consider its decision and upon resuming it was

RESOLVED: That, having considered the complaint and the representations of the driver and their representative, the Regulatory Committee were satisfied that the driver remained a fit and proper person to hold a Joint Hackney Carriage and Private Hire Drivers' Licence within the Dover district.
