Purpose of the report: Replacing corporate laptops due for replacement in 2022/23.

Recommendation: To approve a new project to replace laptops used by Council staff

which are due for replacement in 2022/23.

1. Summary

1.1 To replace up to 100 laptops currently in use by DDC staff with the latest HP ProBook laptops which are located across all departments in the Council.

2. Introduction and Background

- 2.1 The HP 250 G6 laptops were initially released in 2017. They are now 5 years of age and the number of laptops failing is increasing.
- 2.2 As part of the rolling replacement programme, the HP 250 G6 and Dell Latitude 3380 models are the next to be replaced.
- 2.3 The Dell Latitude laptops were transferred to DDC as part of housing being brought back in house. There are 7 of these laptops still in the housing department.
- 2.4 The HP 250 G6 model is distributed across all departments.
- 2.5 DDC has been purchasing the HP ProBook series laptops due to their better build quality and connectivity with the HP docking monitors, making working easier.

3. Identification of Options

- 3.1 Option1 Do not replace.
- 3.2 Option 2 Replace with the latest HP ProBook models.

4. Evaluation of Options

- 4.1 The option to not replace the laptops has been considered. The laptops being replaced are now 5 years of age. They are not running efficiently, making boot up and shutdown times longer and as newer software requires higher specifications, these will continue to become slower. There has also been a larger number of issues/failures with these laptops over the past 12-18 months.
- 4.2 Application reliability scores are showing the models due for replacement are under 70% reliable, compared to newer models rating at 100%. This means applications are crashing more often on the older models, affecting productivity.
- 4.3 DDC has invested in the Microsoft 365 system, as part of this DDC can upgrade to Windows 11 to continue to make the most out of the new features available. The models due for replacement are not compatible with Windows 11, the replacement will allow DDC staff to benefit from the newer software. New features and functionality

from Microsoft will only be added into Windows 11 and Microsoft support is based on the version of Windows being used. Windows 10 support will run out in June 2024.

5. **Resource Implications**

- 5.1 There is budget allocated in the ICT reserve for this project.
- 5.2 The cost of computer hardware is still fluctuating and is vulnerable to global events, the table below shows the costs of 2022/23 replacements based on current pricing.

- 5.5 ICT resource will be required to asset, build, and deploy the laptops. This will be completed through a planned schedule.
