## General Exception

Pursuant to the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

### Notice of Key Decision

**A: Decision to be taken and by whom**

To receive an update on business operations at Dover District Leisure Centre.

Cabinet on 6 February 2023

This is a Key Decision which has not been included within the Notice of Forthcoming Key Decisions, but which must be taken by such a date that it is impracticable to defer the decision until 28 days after the next Notice is published.

**B: Reasons why this Key Decision was not included in the Notice of Forthcoming Key Decisions and why it would not be practicable to defer the decision**

The Notice of Forthcoming Key Decisions published on 6 January 2023 did not include an item regarding business operations at Dover District Leisure Centre because discussions with Places Leisure in relation to the management fee have only just concluded.

It is not practicable to defer the decision because it impacts on the Council's budgetary provisions for 2022/23 and the Budget allocations for 2023/24 which are due to be considered by Council on 1 March 2023.
