## The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

### Notice of Intention to Hold a Cabinet Meeting (or parts of it) in Private

*The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 came into force on 10 September 2012. These prescribe that 28 clear days' notice must be given by a decision-making body where it intends to hold the whole or part of a meeting in private because confidential or exempt information would otherwise be disclosed. Members of the press and public will be excluded from the meeting during consideration of these items.*

**NOTICE is hereby given** that the Cabinet of Dover District Council intends to hold the meeting (or parts of the meeting), of which particulars are given below, in private for the reasons set out below.

This is a scheduled meeting. The press and public will be excluded during consideration of the following exempt agenda items:

- Purchase of 30 new houses for affordable housing at Cross Road, Walmer
- Development of Council-owned land at Grove Road, Preston for affordable housing
- Delivery of affordable housing at site at Military Road, Dover
- Approval of project to purchase new-build properties for use as affordable housing at Wallers Field, Deal
- Approval to repair a number of built assets/structures at Kearsney Abbey and Russell Gardens
- Approval of new 5-year lease for DFDS for units at Whitfield Court, White Cliffs Business Park
- Update on alternative solutions or sources of external funding for delivering Tides Leisure Centre project (to be confirmed)
