 - 1.1 At its meeting held on 13 May 2024, Cabinet resolved to defer four of the appointments to outside bodies pending further information. These were Municipal Charities of Dover (two trustee appointments), the River Stour (Kent) Internal Drainage Board (IDB) and the Sandwich & Pegwell Bay National Nature Reserve Steering Group (SPBSG).
 - 1.2 Following consultation with the bodies and existing appointees, the Leader of the Council has decided to reappoint Councillor Moorhouse to the IDB and SPBSG for a further term of one year, and Mr Roger Walkden and Mrs Ann Jenner to Municipal Charities of Dover for further terms of three years.
