## Brief Details of Item:

The report sets out the need to review the existing Council Tax Support scheme, and why the review is needed. Approval is sought to consult on a public basis. Public consultation is a legal requirement if the Council Tax Support scheme is to be changed.

## Deadline for Item:

The decision is needed on 5 August for operational reasons initially. Then, post-consultation, the results will be brought back to Cabinet (date to be decided) for a decision as to whether or not to recommend to full Council a revised Council Tax Support scheme.
