Appendix 3 – Public Comments

Comments 1 and 2 - from same member of the public

Comment 1

Dear Sirs

I write to you in respect of the above meeting and the Council's decision to hold it in private, with members of the Press and Public excluded. I object to this for the following reasons below, and respectfully ask the Cabinet/Executive/Trustees to reconsider with a view to allowing the Press and/or Community representation to attend. The disclosure of financial elements could be held back until a decision has been made, unless the Cabinet/Trustees have already determined to grant a lease of the Pavilion and Ground at Marke Wood Recreation Ground.

This whole episode has only recently been brought to the attention of the local Community of Walmer, through the affixed Notices of Application for a Premises Licence for the Sale of Alcohol at the Pavilion at Marke Wood and sought by the Cinque Ports Football Club, which Application was subsequently withdrawn by the Football Club before the scheduled meeting on the 15th August next.

It then came to light, once I requested a copy from Dover District Council (DDC) of the Restrictive Covenants that were included in and attached to the initial Transfer of Title in Marke Wood to the Walmer Urban District Council and pertain, in perpetuity, to that land, that a meeting to discuss the leasing of the Pavilion and Ground at Marke Wood Recreation Ground to the Cinque Ports Football Club had been arranged for sometime in September. The identified User within the Transfer and Restrictive Covenants is clearly the Community/inhabitants of Walmer, as the land was given for that purpose by the Marke Wood family. What has been constructed on that land is not for the benefit and use of a sole entity, such as a single football club, and on a permanent basis as inferred in evidence below.

It would have been much more open of the Council/Cabinet/Executive, who will be acting as trustees for the Charity of Frederick Franklin for a Public Park (Charity No 1092171), to have put any proposals or considerations for the potential future use and occupation of the Pavilion and Ground, out to the Community of Walmer at large. There has been much talk of making use of the Pavilion and Ground, including the Tennis Courts, by members of the Community for the benefit of the Community, including visitors, and they would have welcomed discussions with the Council in that respect.

I further note, under the submission to the Charity Commission in respect of the Charity of Frederick Franklin for a Public Park (Charity No 1092171) in 2008, that the purpose of this Charity is: Land at Marke Wood to be used for recreational activities of the inhabitants of Walmer. The Cinque Ports Football Club originates from Deal Town Rangers Senior Football Club before changing to Deal Sports FC and not Walmer. I quote from an article in kentonline dated 5th July 2019 in which Mr Bowers and Mr Chivington, the 'owners' of the Club state:- 'Mr Bowers said: "We've been in discussions with DDC about a permanent home for our club for years and this here is a continuation of that process. They've encouraged us to play here because no one was using it. We're delighted with the opportunity and incredible support from DDC, and we hope to see a lot of new faces as well as old." In addition to the pitch, they plan to adopt the adjacent building to create a club lounge for players which will also serves refreshments to spectators.' You will note that there is no mention of the Community in all of this and the reference to a permanent home including the Pavilion and Ground must be contrary to the Restrictive Covenants attached to the original transfer of title, referred to above. I also note that there is a Deal Town Rangers FC in existence providing football for over 250 young people in Deal and the surrounding areas.

The Trustees of the Charity of Frederick Franklin for a Public Park (Charity No 1092171) - Dover District Council who also established the Charity - must have regard to these Covenants otherwise they would be failing in their duty towards their said purpose: Land at Marke Wood to be used for recreational activities of the inhabitants of Walmer. There is and was an alternative option for DDC/Trustees/Executive to consider and that is for the Community to manage the entirety of Marke Wood, under the guidance of the Charity and its Trustees, as a recreational ground for all sports and recreational purposes, as the Community is the User of the Ground. This would extend to the running of the Pavilion and Tennis Courts with a greater openness for the Community and visitors to utilise. To grant a lease to the Cinque Ports Football Club gives a sole entity legal occupation of the Pavilion and Ground at Marke Wood for a term of years and would be subject to renewal, all to the exclusion of the Community. If Cricket was to return to Marke Wood, there would be no facilities to

accommodate teams, in terms of changing facilities etc. This scenario that we are now faced with could not have been considered at the time of the initial transfer from the Marke Wood family, as for this kind of transaction to be contemplated, it would go against the legally enforceable Covenants attached to that initial transfer. To grant such a lease on the Pavilion and Ground to a single entity would effectively change Marke Wood Recreation Ground for ever, you would never get it back.

Only last night, Tuesday 6th August, whilst training was underway, I was alerted whilst in the garden, by some crashing sounds - something hard on metal. I went out into the park and noticed two young children in the Children's Play Area throwing something onto the slide and the merry go round. I also noticed one of the children throwing stones onto the roof of the Pavilion. This must have been ongoing for at least 20 minutes. A neighbour, whose garden backs onto the Children's Play Area, was also attracted by the sound. An altercation took place with the mother of one of the children which could have become unpleasant. The mother then retorted to someone on the playing or coaching staff - "more complaints coming" - but there was nothing forthcoming from the player or Coach. I make this point because there has been little attempt by the CPFC to meet with the Community and discuss plans, other than a letter dropped through the letter box after objections were raised about the Application for a Premises Licence to sell Alcohol, and I can only see this ending in disaster.

Comment 2

Dear Councillors

I write in reference to a meeting of the Cabinet, when the members will be acting as Trustees to the Charity of Frederick Franklin For a Public Park, to be held on 2nd September during which the leasing of Ground at Marke Wood and its Pavilion to the Cinque Ports Football Club is to be discussed.

I object in the strongest terms to the land, or parts of it, and the Pavilion being effectively granted to a private enterprise or a single entity for its benefit alone and through a legal interest. In so doing, the community, by and large, lose the full amenity of Marke Wood that is guaranteed under the terms of the Restrictive Covenants that formed part of the original transfer of title in the aforementioned land to Walmer Urban District Council. Football is largely a Winter pursuit in the UK but putting the legal interest in land and Premises into a single entity prevents the Community from occupying those aforementioned elements throughout the year.

By proposing or, indeed considering, this means of transfer marks a change in practice from individual sports renting the recreation ground and Pavilion to granting a leasehold interest to a single entity for their sole enjoyment and benefit which will remove those aspects from the Community's enjoyment and thereby change the nature of Marke Wood forever.

I urge you to reject any granting of a lease that would create a legal interest in land and premises at Marke Wood to the benefit of a single entity and retain Marke Wood as a Community amenity for the "use and enjoyment of the children and people of Walmer", as it stipulates in the Restrictive Covenant and is indeed contained within the purpose description of the Charity of Frederick Franklin For a Public Park (Charity Number 1092171) – Land at Marke Wood to be used for recreational activities of Walmer inhabitants.

Comment 3

MARKE WOOD RECREATION GROUND CINQUE PORTS FOOTBALL CLUB

I am writing to you in your capacity as Vice-Chairman of the Cinque Ports Football Club. Yours is the only address I have.

Last Tuesday, 6 August, I was sitting in my house watching the TV when I heard loud and continuous metallic 'banging' noises coming from the children's play area in Marke Wood. As this continued for some time I felt obliged to investigate. I discovered that 2 small boys were throwing large lumps of stone/tarmac at the play equipment.

I attended the scene and remonstrated with the boys, asking who they were with. I was told, by one of the boys, that Dad was playing football and Mum was sitting on a bench. I observed the mother engrossed on her mobile phone. I was surprised that she had not heard the disturbance as the bench was near the pavilion and closer than I was at home.

Another neighbour, further away, had also been alerted to this disturbance and had attended independently and observed the behaviour.

I attracted the attention of the mother, who came over. She was told of the attempted vandalism and retaliated in a somewhat aggressive manner. I suggested that the children should be supervised and was

told that she had been attending to her 'brother's bench' that had been vandalised. When I first saw her she was not engaged in any activity, apart from viewing her phone. She clearly could not see the irony of the bench being vandalised and the attempt at damaging the play area by her son.

Because of the aggression of the mother, I did not stop to investigate if any permanent damage had been done to equipment and withdrew.

I should be grateful if you would remind your members to respect all areas of Marke Wood and supervise their children when attending events hosted by your club in Marke Wood. There is concern that this incident will not be isolated and the behaviour of supporters questionable.

I am pleased to see the use of Marke Wood for football but am opposed to the sale of alcohol in the area, or a lease given to one particular entity when Marke Wood was gifted to the people of Walmer for general public use and enjoyment.
