Reason for the Decision:	To confirm the on-street parking charges for Deal and Walmer.
Decision:	To agree that the on-street parking charges for Deal and Walmer shall be as set out in the table annexed to this Decision Notice.

1. Background

- 1.1 At the Cabinet meeting on 1 February 2021, Cabinet gave its approval to a revised schedule of parking charges to apply across the District. The draft minutes for the meeting record as follows:

It was agreed:

- (a) That the outcome of the annual review of parking charges be noted.
- (b) That the proposed parking charge options set out in Appendix 1 of the report be approved, subject to the proposed permit charges being reviewed for consistency, particularly in respect of vehicle emissions.
- (c) That the Transport and Parking Services Manager or Head of Commercial Services be authorised, in consultation with the Portfolio Holder for Transport, Licensing and Community, to take all necessary legal and procedural processes to give effect to the agreed recommendations as set out in Appendix 1, including the giving of notices and the making or amendment or any orders under the Road Traffic Regulations Act 1984.

- 1.2 Subsequent to the Cabinet meeting, it has been noted that the tables within Appendix 1 of the report setting out the on-street charges for Deal and Walmer and the off-street charges in Deal contained minor errors relating to both the current and proposed charges.

- 1.3 The recommendations contained within the report did not intend there to be any changes to these charges, a point made clear within the report, which states that any changes proposed to the current charging structure are highlighted in yellow.

- 1.4 However, to avoid any confusion, the relevant tables have been amended as set out in the annexes attached with the corrected figures highlighted in red.
