**Proposed revision to the residents' parking scheme, area's affected; All residents in the Zone H, L, P and N permit schemes in Deal.**

Historically, the permit schemes that are in place in and around Deal worked well but as with everything, they need to be reviewed for them to work in the future. Parking Services are proposing to put in place a change to what permits are to be used in the various areas in the town.

**Zone L;** has been proposed to cover residents in Victoria Road, Sondes Road, Stanley Road, Clanwilliam Road and Ranelagh Road, as well as Hope Road, Gilford Road, Blenheim Road, Beaconsfield Road, Wellington Road and Northcote Road.

**Zone P;** has been proposed to cover residents in Beechwood Road, Astor Drive, Mill Road (part of), London Road (part of) and Bridgeside.

**Zone H** will still remain in roads north of Queen Street, including Queen Street (part of).

(Roads maybe added to the above zones in the future, should it be necessary)

I am therefore writing to enquire whether, or not, you would support the changes of the residents' parking schemes along your road and in your area.

Please find enclosed a plan showing the extent of the residential parking scheme changes being proposed for your area. We are not changing the times or days the permit scheme covers at this moment, but this might be reviewed dependent on the responses from residents.

To help gauge the views of the residents, could you please indicate your preference for, or against, the proposed changes to the parking schemes by filling in and returning the enclosed questionnaire, to reach this office by 12noon on XXXXXXXX 2021. Alternatively, you can reply via email (using the address detailed above) stating whether, or not, you support the proposed scheme. Please ensure that any emails are delivered by 12noon on XXXXXXXX 2021 and that they include your name and postal address

If the majority of responders support the proposed scheme, agreement will be sought from councilors on the Dover Joint Transportation Advisory Board (JTAB) to formally advertise the proposal. Conversely, if the majority of responders' object, it is likely that the JTAB will abandon the proposal. Alternatively, if all but one or two roads support the scheme, it's possible that a variant scheme could be considered.
