Part 4 Council Procedure Rules	18.8	AMENDMENT Insertion of additional text (in red text)	<u>Voting in Committee and Sub-Committee</u> <i>This rule only applies to Committees and Sub-Committees.</i> All questions in Committee and Sub-Committee shall be determined by show of hands <i>or by means of an electronic voting system, or if there is no dissent, by the affirmation of the meeting</i> by majority of the members present and voting.
