<p><b>Brief Details of Item:</b> (Please provide information about the contents of this item and the reason for decision.)</p> <p>The Council is preparing a bid for the Levelling Up Fund (LUF) Round 2. As outlined in public engagement activities during the week commencing 13 June, the proposal comprises land assembly and regeneration at Bench Street, Dover. Outputs will include a circa 2,000m2 creative campus providing training opportunities in creative and digital industries, business, a circa 700m2 business centre providing flexible affordable facilities, expansion of the Dover Cycle Scheme, 450m2 of public Electric Vehicle parking and charging and 800m2 public open space.</p>			
<p><b>Deadline for Item:</b> (Please indicate the date and whether this is statutory, operational or to meet the requirements of another agency.)</p> <p>Any funding awarded through the LUF programme must be spent by March 2025, a challenging timescale for this ambitious project. A decision regarding the funding application is expected during autumn 2022, but it is necessary to select a procurement route for partner organisations and the professional consultant team in advance in order to ensure that the Council is in a position to appoint partners, consultants and contractors as quickly as possible.</p>
