<p><b>Brief Details of Item:</b> (Please provide information about the contents of this item and the reason for decision.)</p> <p>It has been identified that the existing Public Spaces Protection Order (PSPO) needs to be varied. This is required in order to add additional dogs on leads and dog exclusion areas.</p> <p>Further to this it has been identified that a variation to the wording is required for item 5 on the PSPO 'Consumption of alcohol in public places'. This is required in order to provide clarity on the enforcement area to include 'within the administrative area of the Authority namely the Dover District Council Area'.</p> <p>A public consultation has been carried out following Cabinet approval in September. The findings will be presented to Cabinet to seek authority to make the changes to the existing Order.</p>
